# Notes for JOHN CHAMBERS:

This data is from James Chambers, my Indiana Jim. On June 26, 2003, Jim says, "the last find I have on the Chambers family is that John Chamber of New Jersey was born there for certain, not in Northern Ireland as was thought might be possible." Sommerset County and Middlesex county, NJ. Jim indicates that John's mother was foreign born, father born in U.S.

The will of John Chambers, written March 1855, found in Ohio. "In the name of the Benevolent father of all I, John Chambers, of lawful age and sound mind do make and publish this my last will and testament. I will and bequesth and devise to my beloved wife after paying my funeral expenses and all my just debts. All the remainder of my property both real and personal so long as she lives and remains my widow.

If my beloved wife Mary Chambers should marry again then she shall forfeit all her claim to my property both real and personal. If she should not marry at her death I will all my property both real and personal after paying her funeral expenses and just debts be equally divided between my children to wit Jacob Chambers, Rachel Penrod, Jane Horner, John Chambers, Maria Hedrick, Will Chambers, Francis M. Chambers, James Chambers, Matthew Chambers. I will and devise that they shall be provided both for me and my beloved wife out my property aforesaid suitable Grave Stones to be placed at our Graves.

I will that my wife be and is hereby appointed sole executrix of this my last will and testament.

i DO HEREBY REVOKE ALL FORMER WILLS BY ME MADE. IN TESTIMONY WHEREOF I HAVE HEREUNTO SET MY HAND AND SEAL THIS 30THE DAY OF MARCH 1855.

The order of the children is approximated, based on this will. At first it was not known that John married twice, first to Mary McKean, who was mother of the children, then next to widow Mary Morris. This gives the dilemma of first Mary being dead before him, and his own new wife, Mary, who died after him and is buried near him in Oran Cemetery.

# Generation No. 2

**2.** RACHEL<sup>3</sup> CHAMBERS (*JOHN*<sup>2</sup>, *JACOB*<sup>1</sup>)<sup>2,3,4,5</sup> was born 14 Mar 1805 in New Jersey, and died 22 Jun 1868 in Shelby Co Ohio. She married SAMUEL PENROD<sup>6,7</sup> 11 Sep 1822 in Montgomery County Ohio<sup>8</sup>. He was born 1794 in Pennsylvania.

# Notes for RACHEL CHAMBERS:

Married Samuel Penrod in Shelby Co. Ohio, born in Pennsylvania. He and Rachel had 6 children, of whom one, William, is said to have died of inhumane treatmen t by the Confederates at Andersonville Prison in Georgia.

The history of Miami County Ohio says Rachel was born in New Jersey. Her obituary from the newspaper of July 2, 1868 says she was born in New Jersey, Sept 14th 1804, and when she was two years old her father with his family moved to Montgomery County Ohio where she lived about thirty years. (This indicates she came to Ohio about 1806.) She married Samuel Penrod Sept. 12th 1822 who moved the family to Shelby County Ohio in 1832. For the last 30 years of her life she was in ill health, and her last illness was short yet very severe and painful. She left a husband and six children to mourn her lose.

#### Notes for SAMUEL PENROD:

Samuel Penrod was a pioneer settler and preacher in Shelby County Ohio. He was born in Pennsylvania of German ancestry, and during the whole of his mature life he engaged in farming and in serving as a minister in the Christian church. He was instrumental in building the old church at Newport. His wife Rachel was a native of New Jersey.

They had six children, Jacob and Mary Jane, deceased, Phebe Ann, Levi, and William. William served in the Union army. He died from starvation and inhumane treatment while held a prisoner of war at Andersonville Prison Camp in Georgia during the Civil War.

# Notes for MATTHEW CHAMBERS:

Matthew was the youngest son of John Chambers, born in Ohio. Though data is thin, it is believed he worked around as a farm laborer, and met Elizabeth Ann Havens when both were young teenagers. Elizabeth bore their first child before their marriage when both were only fifteen. This put great pressure on Matthew to constantly find a home for his family and to work hard as a hired farm laborer, often a tenant farmer. The couple moved often about Ohio and into Fulton county Illinois with family as Matthew earned the family living. Perhaps they did not stay in Illinois until about 1860. They also moved back and forth to Holland Michigan where the men of the family worked in the very busy timber industry.

He is listed as illiterate in the 1870 US census of Fulton county Illinois. He worked hard to support his family of wife and ten children. He was lucky to maintain his health, and to have a strong, healthy wife who did not die under the strain of bearing so many children and the stress of tending such a large family. Many men of this era "wore out" wives by excessive child bearing, often having to marry two of three more women to tend their large families, but Matthew was blessed with the strong and healthy Elizabeth.

Old Matthew travelled to Dakota Territory and took up a homestead. It was across the road from widow Sarah Pierce and her three little daug hters. There is no evidence of exactly when Matthew actually worked on his acreage, but his oldest son William and family were with him as were others including Levi and Francis

Marion, as well as daughters Marilla with husband Gilbert Mack, Sarah and husband Perry Landis, and youngest daughter Augusta. Matthew died there and has recently been found buried in an unmarked grave in Delmont Cemetery.

The Receiver's Receipt No. 2891 from the Receiver's Office at Yankton was issued November 20th, 1883. "Received from Mathew Chambers of Douglas County Dak. the sum of two hundred dollars and --- cents being in full for the South West quarter of Section No 28 in Township No. 99 north of Range No 62 W, containing 160 acres and --- hundredths, at \$1.25 per acre, Jos G Chandler, Receiver" The separate Patent Record is issued 5th December 1898 sealed by C.E.Huston, Register of Deeds, signed by Grover Cleveland, President, 2 April 1887.

The homestead of Mathew Chambers was diagonally across from that of Sarah Pierce. When viewed by author on the site, there was no sign of any buildings and the place at the corner was in tall slough grass. The main working county road ran across in front of the site, the cross road did not run on the line past the Chambers place. A good branch of Choteau Creek flowed through Sarah's site, and over across into the place across the road, beside Mathew's. It was a wet year and the site was a wetland, a pond, a slough, with trees and high wetland reed grass. Sarah's place showed an overgrown shelterbelt between the creek proper and the house site. The house was gone, but there were at least three wood buildings, one a very large two-story barn.

# Notes for ELIZABETH ANN HAVENS:

Though Elizabeth Ann Havens is listed as having been born in Montgomery County, Ohio, and her marriage to Mathew Chambers is in the marriage lists, her exact parentage has not been fully verified. There are a number of Havens families in early Ohio, some with older women named Elizabeth, so that she might have been named for a grandmother. The date and place of her death is also not proven, though there are several theoretical times and places proposed.

Hilda Manbeck Vandervelde showed a letter, now lost, which came from Illinois, in which Eliza herself illiterate, sent a proposal at the death of daughter-in-law Percy Hoadley Chambers, wife of F.M Chambers, who died in Douglas County South Dakota about July 1885, and was buried in Grand View cemetery. She left behind a large family with her husband. In this letter, Eliza proposed through the writer that if Marion would "get rid" of the two oldest girls, Lillie Ann and Etta Belle, a woman living near her in Illinois would marry him. No anwer to this proposal is known. I did not copy or memorize this letter, nor do I recall now, about 45 years later, exactly who wrote the letter or where they lived.

Some family members believe that Elizabeth accompanied the family to Dakota Territory, but this has not been proven. She might have done so, and died there. Someday this data will be found.

# Notes for AUGUSTA (GUSSIE) CHAMBERS:

Her records are vague. She moved to Dakota with her older brothers and father. On 6 August 1894 she was witness to the marriage of Frances Marion chambers and Danae Pierce Chambers in Grand View. The other witness was Henry Millay. It is likely but not yet proven that she died in douglas County about 1900 leaving at least 2 children, and might have borne a third baby, the "Florence" menti oned in some records. There are 2 children living with Henry Millay and wife E tta Belle Chambers Millay, but are only found in one census and that census is very difficult to read. They do not appear in that household again. Her husba nd migrated away from the area.

#### Notes for WILLIAM H. CHAMBERS:

William, known as Uncle Billie by his nieces and nephews, was oldest Chambers brother and a Union Army veteran, was often the main support of his slow brother, Francis Marion. His middle initial H is sometimes said to stand for Harrison, sometimes for Havens, the maiden name of his mother. William enlisted August 8, 1862 at Tonica, Illinois for a term of 3 years for service in the civil War. He was mustered into service August 27, 1862 at Ottawa, Illinois. He was assigned to duty as a Private in Company B., 104th Illinois Infantry. His description at the time of his enlistment was: age 20 years almost 21, height 5 feet 8 iunches, Hair light, Eyes blue, Complexion light. Occupation, farmer. Nativity, Ohio, Residence Tonica, Illinois, according to his enlistment notes in his official pension file from the National Archives.

He and several brothers had been working in Michigan in the timber industry, and he returned there to Holland, Michigan after his discharge from the army in 1863 on Disability. His pension papers state that he had been captured by the Confederate Army in Tennessee along with four others of his unit, and remained in enemy hands for ten days. Parolled back to their own army at the end of that time, all five were sent for physicals as was usual upon return from the Rebels because they were often exposed to disease, and not properly fed. The other four men were quickly returned to duty, but William was discharged because of an existing condition, a collapsed lung from tuberculosis, which had obviously been present when he enlisted, but no real physical exam had been given upon enlistment.

Back home, he soon returned to Holland, Michigan, after marrying Helen Bulloch in LaSalle county Illinois, near Tonica. Their first baby, a little girl named Laura Mable was born in 1866 and died that same year. Their first son, Archie, was born Michigan in 1867. Other members of the family were there too. Brother Francis Marion married teenager Percy Hoadly there in 1865 with his parents Matthew and Eliza Chambers as witnesses to the marriage according to the certificate from the County Courthouse. The families moved back to Fulton County where Hellen bore two sets of twin boys, of which three died and are buried in Fulton County. She bore two more children, girls who died shortly. She then bore daughter Nettie, who survived to adulthood. About 1884 or 85 the family moved to Dakota Territory where old Matthew homesteaded a claim, though William did not. Several of his brothers and sisters with wives and husbands also came to live nearby. A clan of family members was always helpful in those harsh times. William was particularly close to brother Levi and wife Lena Landis.

Dakota Territory was not kind to Chambers women. Helen died 9 March 1886. Francis Marion's wife, Percy, died there in 1885, sister Marilla Chambers Mack died in 1887. Helen's children were raised by Sarah Pierce. For several years, Sarah also cared for F.M., and his boys. He had left his two teenage girls with L.J. Manbeck, but still had James Hurshel age 17, Matt age 9, Vadie age 7, and Jesse, age 4. Matt was supposed to

help herd the cattle at L.J.'s house where the 2 older girls worked. Vadie was sent back to Illinois to live with relatives there. James Hurshel also went back to Illinois. Grandfather Matthew Chambers died there too, before proving up his homestead. William bought up the homestead, It was across the road from Sarah's place.

William married Sarah Newberry Pierce in 1887. She was 43 and he was 47. I have stood at the location of Sarah's homestead in Lincoln Township. In 1995, during a period of heavy rain and a long cycle of wet years, there were several large sloughs and low wet places on both sides of the road. There were plenty of big strong trees iat the waterline of the branch of Choteau Creek which ran in the cow pasture of Sarah's place. The farmhouse was gone, but there were a number of still-sturdy old outbuildings including a large barn. A shelter-belt ran along the back of the yard. Across the road, where the Chambers homestead was located, there were no signs it had ever been inhabited, no ruins of old buildings or fallen fences, just a wide wetland with tall grass and cattails. Probably the Chambers family lived in a soddie or a claim shack, and kept their livestock up next to the house.

When he and his first wife, with 2 small children moved to Dakota Territory, F.M. went too, depending on William to help support him and his own wife and family. William's wife died, leaving him with three children and his aged father to care for. His three children were raised by Sarah Newberry Pierce, his second wife.

When William died back on a visit to Illinois, the death certificate states he died of myocarditis, with chronic malaria as a contributing factor. His obituary from the Sioux Falls Daily Press reads "Born in 1842, in Ohio, and entered the Army Service Aug 8, 1862, at Tonica, Illinois at the age of 20. He served in the Civil War in Co. B 104th Illinois Infantry, and was discharged in 1863. William Chambers was a member of the G.A.R. His death occurred Oct. 5, 1913 at Ipava, Illinois, at the age of 73. His remains were sent to Sioux Falls, S.D., where he was buried in Mt. Pleasant Cemetery in Plot 6, block 32, Lot 5, Grave #1st NE 1/2."

His grave in Mt. Pleasant Cemetery in Sioux Falls, SD is marked with a Civil War, Union army grave stone reading "Wm. H. Chambers, Co B 104 Ills. Inf." He always belonged to the veterans organization, the G.A.R. His portrait in his full uniform has been shared by Nettie's family.

#### Notes for HELEN AUGUSTA BULLOCK:

Helen was one of the Chambers women who succumbed to the Dakota Territory weather and hard work. Probably she suffered from the family affliction, tuberculosis. She produced very many children, perhaps eleven, of which only three survived. She was probably not in the best of health from these efforts aggravated by the consumption. She bore a daughter which died, then her first son, Archie W. Chambers, born in Michigan in 1867, where the Chambers family had moved to seek employment in the thriving timber industry. Her exact burial site is not known, but she died in Douglas County South Dakota and might have been buried and reburied into the Delmont Cemetery.

Thanks to Nettie's family, we now have a lovely portrait of Helen taken about 1865. She wears a nice gown of the era and exhibits her wedding ring. At her throat she wears a locket/pin with a picture of William, which is still in the family. This is the only existing picture of her to date.

It is not known who the family is with whom she is living. She is not listed as a servant so perhaps she is a relative of either Wilson or Matilda or even the laborer Morgan. The age is off, but then it is a census record. But it is known in family circles that she was acquainted with William Chambers from Illinois who was at this time living in Michigan and working in the timber industry. She and her siblings might have been orphaned and adopted by relatives. This is being researched by direct descendants. Extensive written notes and letters have been preserved by the family of Nettie Gurtrude Chambers Willi, youngest surviving daughter of Helen and

### Notes for SARAH SOPHIA NEWBERRY PIERCE:

Family legends say that widow Sarah Pierce walked across the prairie from the railhead, pushing her few possessions in a handcart. It is not known if she had her three little daughters with her at that time. She had been living with her mother, siblings, mother's second husband (father's brother) and a second batch of half siblings. In the 1880 U.S.Census back in Iowa, her mother, Sarah Tobin Newberry, widowed and remarried, lived with her oldest daughter widowed Sarah Pierce with three small daughters, Constant Newberry second husband of Sarah Tobin, and children Laura, Mary, Lucy, Claricia from the first marriage with Emma, May, Rosell, and Hazel from the second. Rosell and Hazell, the only sons, also homesteaded into Dakota Territory, settling near Sioux Falls.

The house must have been very crowded. Very much wanting a home of her own, she filed on a quarter section in Lincoln Township in 1883. One corner was drained by a strong branch of Choteau Creek near which she built her first house, a soddie, because she had little money or means to transport building material. Even a nine x twelve wood shanty was beyond her reach. But anyone with determination and good neighbors could put together a soddie.

Certainly her tool kit held a good shovel. She could dig out a rectangle of the prescribed size, saving the sod from the top layer. With the hole about three feet deep, she could stamp down the floor, then cut some large branches or small trees from the nearby creek bank, drag them to the homesite, to build upright corner poles with a top beam. Then she could interweave branches for the roof and walls. The sod could be cut into squares and laid up for walls, all reinforced with branches. More branches were interlaced for the roof, then covered with layers of long cut reeds and swale grass. Later it might be covered with more sod squares, and even lumber, or canvas. Certainly Sarah could not have afforded windows, so she might have left a couple of openings outlined with wood and dropcloths for keeping out the wind. The door was first a heavy hide fastened to a crossbar, and steps made of precious boards or even stones down to floor level. The packed dirt floor was hard and covered with dry grass. The grass could be hauled out when it became infested with fleas and soiled by food or trash, but great care had to be taken so that the little home did not catch fire.

She probably brought a small iron cook stove, some utensils, and a few gardening tools. The first year she must have planted sod corn and potatoes, first crops of most homesteaders. These were planted by punching a hole into the unplowed ground and dropping in seed. Because the black topsoil was so fertile this was often the best crop ever produced on the place. She had the pittance of her Union Army Widow's pension so she could buy staples like salt, sugar, and dried beans. She made trips on foot to the nearest store, walking and pushing her handcart. Later perhaps she rode with neighbors, trading that favor for homebaked pies made with dried apples or homebaked bread.

When the Chambers family came into the area, their lives became intertwined. Old Mathew Chambers applied for homestead rights to the quarter diagonally across from Sarah's place in Lincoln Township the same year she did, 1883. He died sometime before it was proved up, but his oldest son, William with ailing wife Helen and their two surviving children who came in two years later, kept house for him. Helen soon died, leaving William with a family to raise. William did not take up his own homestead, but when his father died he took over that claim. In family legend he had a reputation as a carpenter.

The marriage certificate for her union with William states that William Chambers, resident of Lincoln Township, age 46, occupation farmer, and Sarah S. Pierce, Lincoln Township, age 43, Housekeeper, were duly married on the 17th of April 1887, at 3 P.M. in the presence of Mrs. Lany Chambers (sister-in-law of William) and Mrs. Flora K. Callahan, at home of the Justice of the Peace Callahan in Grand View, Dakota Territory.

A real farmhouse was built on Sarah's place, and in the 1905 S.D. school census, when she was 60 and husband William 63, F.M., Danae, their four young children and Jesse all are listed as living in Sarah's house, because L.J. had sold off his homestead, using the cash in town for his many business deals in real estate, and in running his new livery stable built for him by his father. There was no room in L.J.'s town home for his father-in-law.

As drought and grasshoppers attacked, William lost his father's homestead and another he had bought on a mortgage from a Landis brother-in-law, but Sarah wisely hung onto her own place. In 1906, crowded and stressed, she sold off her successful farm for \$6,400 and retired with William to Sioux Falls.

There they did well, buying several city lots and on which they built rental property. It is said he acted as a building contractor to put up these buildings. From family tales, F.M. had insisted that he was going to turn Democrat, which insulted Union Army Veteran, faithful G.A.R. member William, who had enough of supporting

his constantly dependent brother. F.M. took Danae and the children back to Fulton County Illinois where they were assisted by F.M.'s grown sons as well as his new sons. Later William went back there to visit, probably to reconcile, and died there of a heart attach. But he was buried in Sioux Falls with Sarah. The pictures from Nettie's family include one of the old couple by there pretty new little house on Minnesota Avenue.

His estate was handled by Sarah, and the real property was divided between her and the surviving children of William--Archie W. Chamber age 46 of Lansford N.D., Netti G. Willi, 31 years of age, in Armour, SD, and Albert L. Chambers age 38, at Sheridan Wyoming who are carefully listed in the documents of his estate from Minnehaha County, South Dakota.

Sarah appears in the 1915 SD census, as Sarah Chambers 71, widow, lived in U.S. 71 years, in S.D. 33 years. Owns home. Birthplace Iowa, ancestry French. Her death certificate, from June 9, 1917, was filled in by her brother R.S.Newberry. She died of Bronchial Pneumonia after a Mitral Regurgitation. She was buried in Mt. Pleasant cemetery at Sioux Falls, beside husband William Chambers.

Beautiful pictures have been shared by the descendants of Nettie Chambers, William's youngest child, who was raised by William and Sarah. there is a wonderful group pictures of all the guests at Nettie's wedding, with some 50 or more guests, all posed beside Sarah's charming farmhouse at Lincoln Township near Delmont.

Archie, a farmer like most of the Chambers men, moved from Douglas County up to Lansford Bottineau County North Dakota, near the Canadian border, where he bought a farm on the edge of town according to deeds from County records. Two young children were born there, have birth certificates in the County records. He was the oldest surviving grandchild born to a Chambers.

Archie, the second child of William and Helen, was born in Holland, Michigan in 1867 as recorded in his father's, William's civil war pension file. His baby sister had been born and died before him. Archie married Cora May Hall, born in 1878 in Marshalltown, Iowa, on 10 December 1900 in Armour, SD according to their marriage license and wedding certificates from Douglas County.

Their oldest son, Herbert Archie, was issued a delayed birth certificate by Douglas County, certificate no. 877. According to that document, with Archie signing as the sworn informant 20 February 1937. According to his statement, he delivered the baby himself at 2 a.m. 5 November 1902. And he also says again he was born in Holland City, Michigan, and worked as a farmer on a rented farm at the time of the birth. Up in North Dakota he farmed, but he also built a garage in Lansford where he repaired autos, and other machinery. He also ran a dray service. Nettie's family shared a picture of this business, as well as fine portraits of Archie. He and wife Cora are on the Delmont group Wedding photo.

Archie's sister, Nettie Chambers Willi, was always interested in keeping track of her family, and began enquiries about them among her relatives. She carefully kept these letters and made lists of the births, dates, and other information she gathered. Data from these letters, diaries, and notes will be referred to as Nettie's Research. For most of the children listed on her notes there is only the birth information, with no listing of deaths, burial, or other family data. These may list the birthdays of Archie's children both live and dead, as well as the wives and children of Archie's children.

She was raised by William and second wife Sarah Pierce. She married at age 19, to Peter Willi, son of a Swiss immigrant and 12 years her senior. He had been living among his relatives but took out his own homestead down in Charles Mix County in 1901.

Nettie was a sweet, family oriented woman who left many family photos, clippings, and even journals of her trips back to South Dakota. She also worked at gathering her family history by contacting aunts, cousins, and other Bullock family members. Her notes have been carefully preserved and are being verified and used for genealogical purposes. Her greatgrandson has generously shared both data and photos. He is also making a beautiful book of her diaries.

Raised with her two brothers by William and his second wife, the ambitious and hard-working Sarah Newberry Pierce Chambers, Nettie would have also been close to Sarah's daughters, Viola, Danae, and Minnie.

I have received a copy of the nice printed wedding invitation from William and Sarah, inviting people to the wedding at their home near Delmont. Delmont was about 10 miles north of Peter's homestead site. William and Sarah, with Nettie, lived in Lincoln Township the township above Belmont.

Peter is listed as born in Indiana, in the town now named Buena Vista, in Franklin County. (Data provided by Roland Fisher.)

Samuel and his wife, widow Sarah Harris Deford, who brought her daughter Marian Deford to the family, now had six children in their own marriage, Laney 13, Rosa 11, Oscar 9, Samuel Bert 7, Perry 2, and Lizzie 7 months. Samuel did not follow the migration of many relatives to Dakota.

Danae was the second child of the valiant widow, Sarah Pierce. As a teenager she lived in the crowded house on Sarah's homestead where Sarah cared for all the Chambers men and their motherless children.

Some family members like to pass the rumor that F.M. could not possibly have fathered her first son, and that the boy must have come from one of F.M.'s teenage sons, who also lived in the crowded household. This is possible. But whatever the truth it matters very little because son Lewis Chambers' birth certificate names Francis Marion Chambers as his father.

The Marriage License Application for Marion chamber of Delmont and Danae Pierce of Delmont was filled out by L.J.Manbeck and taken to the circuit court in Armour. He applied for the license answering the following sworn questions: "What is the age of said Marion Chambers? Ans. 48

What is the age of said Danae Pierce? Ans. 20. Are the parties for whom application is made for Marriage License in any way related? Ans. None whatever." And signed by L. J. Manbeck. This application was attached to the license and certificate of marriage, granted on the 6th of August, 1894 at Grand View. The wedding took place August 8th at the home of her parents, and was witnessed by Augusta McGill (F.M.'s youngest sister, and Henry H. Millay, neighbor and friend of L.J. It is said by some handed down tales that Lillie had been angry and insistent that her father marry Danae. She must have raised such a ruckus that L.J., a licensed notary, rode into

town and got the necessary license for his semi-literate father-in-law. Danae was pregnant with her second child Francis Lee who was born the following March.

The familiy is found in the 1900 Census as follows:

- L.J. sold off the old place and F.M. and Danae with children moved back in with her mother, where they are all found crowded together in the 1905 SD school census. After that, Sarah and William sold off their place at a very good price and moved to Sioux Falls. F.M. took his new family back to Illinois to live near his other grown sons with their families, and his other brothers.

Danae was a beloved grandmother to both Gladys and Hilda Manbeck. Gladys in particular spoke of her with great love and affection. She cared for F.M. in his old age. After he died she made her own living taking in laundry and doing housekeeping till she remarried.

Her death certificate is from McDonough County Illinois because she died in the nursing home there. She was 86 years old at death, died of Arteriosclosis. Her certificate was signed by her son, Oma Chambers. She was buried in Pickering Cemetery Section 18, Beernadotte Township, in a section containing many Chambers relatives including husband F.M. and her sister Viola Campbell.

# Notes for LILLIE ANN CHAMBERS:

Lillie was left as a teenager girl with her sister to keep house for L.J. and h is friend, Henry Millay. Lillie married L.J. and later sister married Henry. Lillie, a redhead, was noted for her temper and feisty character. She had thou ght she was marrying a rich young man, because it was obvious his parents and s iblings who moved in nearby to homestead were well-to-do, and her mother-in-law was an educated, sophisticated woman who took great pride in her learning, and her family. Lillie's objections to living in the soddie, stating that it had sickened her child, Wade, may not have been too far-fetched. It can be noted t hat none of the children born in the soddie produced healthy families, though D el had one daughter, herself sterile, and Leora Ruth had one son in her older y ears, he being retarded. Nellie died of a debilitating, crippling disease with no children, and of course poor Charly died without marrying or having children, though his condition certainly could not be attributed to the soddie! Only H ilda and Gladys married and had children in a normal family

situation.

He was noted as a great handler of horses and dogs. He scouted for the U.S. Army at old Fort Randall, became a horseback mail carrier, and then a real estate agent licensed by the U.S. Government to locate homestead claims in the Douglas County area. He was said to have been a regular at local saloons, gambling and drinking. His wife became the support of the family, and most of his children worked as teenagers. In the Court House Dec. 1894 there is noted a suit against his father, David Manbeck, by Fullerton Lumber Co. He owed the money for the lumber used to build a livery stable for his son, L.J.David had signed a note at the Armour State Bank, but had not paid the money. In May 1895, a suit

was filed by the Tripp State Bank against L.J., for \$200 plus interest owed the bank. Perhaps this was part of the same expense entailing the construction of the large livery stable shown in photos of Armour's main street, on the corner lot next door to the Lumber yard.

There are at least a dozen suits in the court records against various real estate customers for whom he sold farms in hard times. They owed him a contracted fee for this, but many refused to pay and tried to move out of state before he could collect, but he usually collected.

#### Notes for ETTA BELLE CHAMBERS:

Etta Belle was given away by her father after her mother died, and lived in the sod hut owned by L.J.Manbeck, with her older sister, Lillie Ann. L.J.Manbeck was an ambitious and busy man, always riding off to escort new real estate clients into the county. People stayed overnight at his place, and the two girls were there to serve as cooks and housekeepers for everyone. In the old picture of the place there does not seem to be enough room for many people. Probably there was a barn nearby where folks bedded down in the straw overnight. Probably there was a bunkhouse where the two girls and their younger brothers who stayed to help with L.J.'s cattle, also slept.

According to Douglas County History there was a calf-barn attached to the soddie. It was in this calf-barn that L.J. and his older brother B.F. installed an itinerant pressman and his valuable press, printing up the first newspaper in the area. It was that newspaper which wrote about the criminal activities of the Brown Gang who activated a fake County government to make money for themselves and their cronies, embezzling funds and cheating local citizens. Distributing that newspaper into cities all over the more civilized states brought action from the law and Jeff was one of those creditted with throwing out the crooks.

L.J. was a dynamic and attractive man, so it is no surprise that family legends say that both girls fell in love with him. The same legends also relate that Etta was jealous when L.J. married Lillie. She married L.J.'s best friend, Henry Millay.

While L.J. may have been more attractive and exciting, Henry was certainly the better home provider and always gave Etta a good house with plenty of food and probably household goods of her own. When they separated because of Henry's affair with his brother's wife, Minnie, Henry turned over all his property to her so that she was assured a financially secure life. Luckily she had a strong, personable, and very hard-working nephew, Aurbie Chambers, to take over the man's place around the farm. She signed the whole place over to Aurbie and he lived with her till she died there.

Sadly, Ettie never had children of her own, but she always valued her many nieces and nephews both in South Dakota and back in Illinois. Vance and Alice Vandervelde, children of Etta's niece, Hilda Manbeck Vandervelde, remember her fondly.

### Notes for HENRY HARRISON MILLAY .:

The three Millay boys were raised for the most part by their mother, having been deserted by their father. Many years later their father appeared at Henry's place, old and ill, and died there. He is buried in the Delmont Cemetery. No one has found any recorded details of his life away from his wife and children. Henry settled on a homestead in East Choteau Township near L.J.Manbeck and they became very close friends. When L.J. took the two teenage Chambers girls, Lillie Ann and Etta Belle, into his sod house to be cooks and housekeepers for his real estate customers, L.J. and Lillie married, and then when Etta Belle was old enough Henry married her.

Henry was an ambitious and hard-working farmer who bought out his brother LeRoy and acquired a large,

prosperous farm at the edge of Delmont. He built a nice house for Etta. Perhaps he knew that busy Etta who loved her older sister, Lillie, and children very much, wanted children of her own.

In the 1900 Census of East Choteau Township, when he still lived near L.J.'s old place, the family is shown as follows:

It

is not known who the two children in this census might be. A boy of that age appears in candid photos of Etta, but no pictures of a girl that age have been seen. The children are not with the family in the next census. There is no official adoption record in the Douglas County Courthouse, and it is not known who their parents might have been, but perhaps these were the children of a family member of Etta, whose young Chambers aunts lived in the state, and died nearby.

Later when his younger brother Dan was serving time in prison, Henry reportedly had an affair with Dan's attractive young wife, Minnie Pierce Millay, who lived nearby. Certainly as a good farmer, he would have helped her keep up the hard work around his brother's place. But poor Etta could not forgive him and "kicked him out of the house." Ownership of everything was then made over to her, and she took over running the farm, with help of her handsome young nephew, James Aurbet Chambers, who moved there at the end of his Navy service during World War I.

In the History of Delmont, Henry is mentioned twice as one of the prominent persons nearby in early days in reminiscences of elderly settlers. The newspaper of July, 1905 reports a Dance was held at Henry Millay's, with sale of 27 tickets!

After some time Henry became very ill and Etta took him back into her home to be nursed there until his death of "pernicious anemia" in 1926. Details are from his death certificate from Douglas County.

On Lewis's birth certificate, Francis Marion Chambers is named officially as the baby's father. It is not really possible to determine if F.M. was making this gesture to help both his older son, and Danae, his own wife, who subsequently bore him three more children, but Lewis was raised as a child of F.M. and

He is said to have married Nellie Littlejohn in fulton County II 1 August 1895, but apparently no children were born to this marriage and the marriage ended, just how it is not known from records.

The other boys stayed there for awhile, caring for the livestock for L.J. because he was not a farmer at heart. Evidently Jesse remained in SD till 1905 when F.M. and Danae moved to Fulton Co. Illinois. He and his family lived in Cass Twp of Fulton County. In 1926 he and his family went to Delmont where they lived for a year with Etta Belle Millay and Aurbie. In 1928 he returned to Smithfield, Cass Twp., Fulton Co. where he remained for the rest of his life.

survive the harsh prairie life. But very little verifying data has been found, and it is hoped that more can be discovered because the Wenzel families descended from her daughter have contacted us.

Jim Chambers, descendant of James Hurshel, has done extensive "cemetery hunting" on site in Douglas County. He has evidence that Marilla was first buried in the same Grand View Cemetery as was Percy Hoadley Chambers. According to Jim, he found evidence that she might have remained there, although Etta Chambers Millay arranged to remove Percy from the defunct and deserted Grand View area, putting her mother into her own plot where Percy lies to day beside Etta. Jim found evidence that William Chambers bought a plot in Delmont Cemetery. He believes that Wm. bought this plot in which to inter his old father, Matthew. This is now marked with a stone bought by the family when Jim verified this data. Jim says that he studied the original cemetery listing book of the caretaker and found that the "Mrs. Chambers" had been originally labelled "Hur Chambers" which Jim believes stands for Hurshel Chambers. JIm believes that Hurshel's first wife, mother of Aurbie and Etta, died in childbirth at Delmont while visiting from Illinois, and was buried there near Matthew. However, the travel diary kept by Nettie Chambers Willi, daughter of William, states clearly "We went out to the cemetary where Mama (Helen Bulloch Chambers) is buried. Her grave is fine, but Grandfather's grave is all sunk in at the foot. Aunt Sis' grave is in fine shape...." By other names she gives, this is the Protestant Cemetery at Parkston, Hutchinson County, SD. But there is no marker for her.

A different clue comes from looking at the WPA list for the Evangelic Cemetery, which lists the marked graves for that cemetery, which include Mack Plot, on which is buried Perry S. Mack, mal, died 1896, age 16, lot 2, grave 2. Jim chambers says there is an unmarked grave beside the boy. This is at the church which Marilla and Gilbert attended, located in Douglas County, up near the Hutchinson Co. line. There are graves of three members of the Parfitt family, JOhn G. age 50, Millies age 27, and Pearly age 13. Marilla's oldest child, Henry, married Ada Nevada Parfit.

Previously, before July 2003, I had never seen any indication that this couple had children other than William E., whose delayed birth certificate with affidavits is in the courthouse records of Armour, Douglas County SD

When the weather turned sour and many Douglas County farmers fled, Levi sold his homestead claim to older brother William, but William was not able to make enough money to keep it and it was sold away from him at a sheriff's auction.

Pictures of Levi have been found, courtesy of descendants of William. The first we received is a group picture taken in Lewistown, Il in 1890 showing five of the sons of Matthew and Eliza Chambers. In this image, a strong and hearty looking Levi stands in the back row looking squarely into the camers. In the other, taken on one of the Delmont area farms, Levi and William are dwarfed by a corn stalk at least ten feet tall, leaning on a building between the two brothers. No date is found on this picture, but that year the corn was beautiful.

Levi died November 3, 1918 during the flue epidemic. His son Billey also had the flu at the same time, but he recovered.

Aflter Levi's death, Lena appears with the family of her son, William (Billey) E., in the 1920 census of Osage County, Bigheart, Oklahoma

Notes for LENA (LANEY) LANDIS:

Lena was one of the family of Pheobe A Littlejohn Landis who intermarried with the Chambers family and moved to homestead in Dakota Territory. She must have been a strong, healthy woman, for unlike several other Chambers women, she survived the harsh life in Douglas County and migrated to Oklahoma.

Laney was the official witness to the wedding of her brother-in-law William Chambers, and widow Sarah

Newberry Pierce on April 17, 1887. She signed the wedding papers and is listed as witness to the marriage.

In the autobiography of son Billey's wife Lelia the young woman writes, "Billey's mother lived with us until her death. March 2, 1921 Billey's mother died. She choled to death, no other explanation was given. Nine days later, March 11, I gave birth to twin girls eight minutes apart."

# Notes for BILLEY EDMRION CHAMBERS:

Named for William H. Chambers, Billey's address in 1943 was Stilwell Oklahoma, Rt 4. His marriage license was issued at Bartlesville, Indian Territory (Oklamona). On his delayed Birth Certificate, issued at Armour, Douglas County, His wife lived at a different address, at Pawhaska Oklahoma. This is explained in his wife's autobiography.

He is listed as "William E." on the 1900 census, given in his father Levi's records. But his name on the birth certificate is Billey Edmrion, a very interesting and rather exotic name.

His future wife, Lelia, moved to Oklahoma when she was thirteen years old. She worked as a house servant for his parents, Levi and Lena Chambers, to earn her way so she could go to school in town. Her family had moved yet again, and lived several miles away. Billey was 19 years old when they married that summer. Soon they moved to Coffeyville, Kansas in a covered wagon. Her wonderful autobiography details her and her family will all births of children, grandchildren, and greatgrandchildren until her 88th birthday, but she lived to 102. The roving, tough life of the family as Billey moved from job to job in the oil fields is very interesting.

# Notes for LELIA FERN SMITH:

Lelia writes, "Hazel (really her aunt) was three and one half months older than I. When we were about four years of age we could try and run off to the brick yard, which was about four blocks away. We never made it to the brick yard, because a neighbor, who never missed anything, would see us and I can still hear her yelling, "Amelia, your kids are running off again." Needless to say we were always brought back home." When Grandpa William lost his brickyard, he moved the family to Brred Station where he worked in a coal mine. "I started school while we lived at Breed Station. When I was a bout eight years old we moved back to Cuba. I got the mumps and since I didn't like Perry (Chambers, married to her blood mother, Florence) very much, I made a special effort to hug and kiss him, hoping he'd get the mumps and he did."
"We moved on a farm when I was about nine. We had about two and a half miles to walk to school. From November until March the snow covered the ground. Sometimes it was so deep it covered the fence posts, and was so cold we could walk on top of the snow."

# Notes for SARAH (SALLIE) CHAMBERS:

Great difficulty has been encountered tracing the daughters of Matthew and Eliza. Sarah "Sallie" married Abram Perry Landis in Fulton County. Her brother Levi Penrod was married to his sister Lena. These two families tended to move together, supporting each other. Sarah bore seven children, the first three in Fulton County then two in Douglas County SD, and her last in November 1890 back in Illinois. She died shortly after that birth. From Dakota, the family had moved to Osage County Oklahoma, just as her brother Levi and husband's sister Lena had done at the same time, first selling off their homesteads.

August 8, 2003, received an updated genealogy of Sarah, which includes data about her children, giving the birth dates of all of them, and the death dates and places of some. She had her first three children in Fulton County, supported by her family. The first baby probably died near birth. Then she had two girls. One married and lived in Illinois. Then Sarah bore a boy in Douglas County. He died in Oklahoma much later. A second son born in SD lived and married in Fulton County Illinois Child 6 was also born in SD, died at age 13 in Oklahoma. The seventh and last child of Sarah, Perry, as born back in Fulton County in Nov. 1890. His mother died near the time of his birth. He lived in Illinois.

#### Notes for ABRAM PERRY LANDIS:

Called Perry by most family members, he married the younger sister of his sister Lena's husband Levi Chambers. Their families lived next door to each other in Fulton county, and the children attended the same school. After marriage the two couples lived in Fulton Co. till about 1885 when they moved to Douglas County Dakota Territory along with Levi's older brothers, William and family, and Francis Marion and family, as well as old grandfather Matthew Chambers. There is no word of grandmother Elizabeth Ann who perhaps had died. Another Landis brother, David, also went along.

They all homesteaded near each other. A neighbor was Johann Wenzel, one of whose sons married Marilla Chambers Mack's daughter. Marilla, older sister of Sarah, had married Gilbert Mack, a neighbor in Illinois. So there were plenty of family members upon whom to rely for assistance.

Sarah died bearing their 7th child back in Fulton County. Perry married another young woman from Fulton County and began raising another family, moving down to Oklahoma near Levi and Lena. He and his new wife are found in the 1910 US Census of Oklahoma, Osage County, Black Dog Twp.

If she should not marry at her death I will all my proerty both real and personal after paying her funeral expenses and just debts be equally divided between my children to wit Jacob Chambers, Rachel Penrod, Jane Horner, John Chambers, Maria Hedrick, Will Chambers, Francis M. Chambers, James Chambers, Matthew Chambers. I will and devise that they shall be provided both for me and my beloved wife out my property aforesaid suitable Grave Stones to be placed at our graves. I will that my wife be and is hereby appointed sole executrix of this my last will and testament. I do hereby revoke all former wills by me made. In testimony whereof I have hereunto set my hand and seal this 30th day of March 1855. Signed and acknowledged by John Chambers as his last will and testament in our presence and signed by us at his request in his presence Wm. Murphey Wm. Skillen.
